Policy I understand that my pet must be in good general health and possess a disposition suitable (no uncontrollable barking or aggressive behavior) to play or stay at Bellingham Bed & Biscuit (“BB&B”). Though all dogs are interviewed prior to admittance at BB&B, this process cannot take into account all aspects of a dog’s behavior in all situations. I understand that I will be responsible for any damage done by my dog to persons or property or other animals. If it is deemed necessary by the staff at BB&B, my dog may be removed from the premises and placed in an alternate boarding facility. If I do not provide alternate care arrangements, or if the alternate care I arrange is not available, the staff will place my dog in the facility of their choosing. This will only occur if my dog is behaving in a way that precludes continued boarding in the kennel-free environment at BB&B. I will be responsible for any and all expenses incurred at the alternate boarding facility. If it is deemed necessary by the staff at BB&B, my dog may be taken for emergency care and I agree to cover any and all expenses incurred. If my veterinarian is unavailable, my dog(s) will be taken to the emergency medical care provider used by BB&B and I will be responsible for any and all expenses incurred. It is my responsibility to ensure that proof of all vaccinations and other requirements is provided to BB&B prior to my dog(s) being accepted for services including boarding or doggie daycare. _____ **Initials**

Release and Indemnification I hereby agree to release and shall indemnify, defend, and hold harmless BB&B and its subsidiaries, assigns, and authorized representatives of all of the foregoing from and against all suits, actions, legal or administrative proceedings, claims, demands, damages, liabilities, interest, attorney fees, costs, and expense of any kind or nature, including but not limited to those arising out of injury to, or death of, my pet, or any other animal, or any person, whether arising before or after completion of the performance of this contract and in any manner directly or indirectly caused, occasioned, or contributed to in whole or in part, or claimed to be caused, occasioned, or contributed to in whole or in part, by reason of any act, omission, fault, or negligence of BB&B or BB&B’s agents, or of anyone acting under BB&B’s behalf in connection with or incidental to my pets participation in any services offered under this contract.

The aforesaid release, indemnity, and hold harmless obligations, or portions of applications thereof, shall apply even in the event of concurrent negligence, BB&B’s sole negligence, or strict liability. BB&B shall be indemnified and held harmless to the fullest extent permitted by law. This waiver was mutually negotiated by the parties, as evidenced by the initials following this paragraph. If any portion of this indemnity clause is invalid or unenforceable, it shall be deemed excised, and the remaining portions of the clause shall be given full force and effect. _____ **Initials**
